Subject: Tentative Map Approval Procedure Ordinance (LA2024-0002)

Location: Citywide

Description: The City of Antioch is proposing text amendments to Antioch Municipal Code Title 9, Chapter 4, Article 1 (Title, Purpose, Scope, and Advisory Agency) and Article 3 (Tentative Maps) which contain regulations implementing the Subdivision Map Act. The purpose of the amendments is to allow the Antioch Planning Commission to approve Tentative Maps, which would streamline the subdivision approval process, making Antioch's process more consistent with neighboring jurisdictions and supporting implementation of Housing Element goals.

CEQA: The adoption of this ordinance is not a project under CEQA, pursuant to CEQA Guidelines section 15378(b)(5) and Public Resources Code section 21065, because it constitutes organizational or administrative activities of the City that will not result in direct or reasonably foreseeable indirect physical changes in the environment. The proposed Ordinance would only establish and clarify administrative processes required by state law and would not approve new construction or other groundbreaking activities. Thus, there is no potential to result in either a direct physical change to the environment or a reasonably foreseeable indirect physical change to the environment.
