Subject: Housing-Related Zoning Code Updates Ordinance (LA2024-0003)

Location: Citywide

Description: The City of Antioch is proposing text amendments to Antioch Municipal Code Title 9, Chapter 5, Articles 2 (Definitions) and 38 (Land Use Regulations). The changes proposed include clarifying the definitions of emergency shelters and major transit stops, adding regulations for the development of employee housing, clarifying development standards for supportive housing and transitional housing, and adding requirements for the provision of replacement dwelling units, consistent with Antioch's adopted Housing Element and state law.

CEQA: The adoption of this ordinance is not a project under CEQA, pursuant to CEQA Guidelines section 15378(b)(5) and Public Resources Code section 21065, because it constitutes organizational or administrative activities of the City that will not result in direct or reasonably foreseeable indirect physical changes in the environment. The proposed Ordinance would only establish and clarify administrative processes required by state law and would not approve new construction or other groundbreaking activities. Thus, there is no potential to result in either a direct physical change to the environment or a reasonably foreseeable indirect physical change to the environment.
