Project Name: Downtown Specific Plan Update

Location: Downtown Specific Plan Area

Description: The City of Antioch is proposing text amendments to the Downtown Specific Plan (DTSP) to

enable missing middle housing by updating development standards; correct errors; and providing greater clarity in certain sections of the text. The original DTSP was adopted on February 13, 2018. These minor updates will enhance clarity throughout the document, facilitate missing middle housing, and update the land use table to comply with State housing

law.

CEQA: The project is exempt under CEQA because an Addendum to the 2003 General Plan

Environmental Impact Report (EIR) was adopted on January 23, 2018 for the DTSP. Minor corrections and clarifications to the DTSP would not alter the conclusions of the Addendum. Furthermore, the project is exempt because the Antioch Housing, Environmental Hazards, and Environmental Justice Elements EIR evaluated the implementation of Housing Element policies and programs, including missing middle implementation, and the proposed changes implement

Housing Element policies and programs.
