Project Name: Tobacco Ordinance Update (LA2024-0001)

Location: Citywide

Description: The City of Antioch is proposing a Zoning Text Amendment to Title 9, Chapter 5, Article 38, Section 9-5.3843 of the Antioch Municipal Code. The amendments would rescind the transfer restrictions, thereby allowing tobacco retailers and drug paraphernalia retailers to sell or otherwise transfer these businesses, subject to all other applicable laws, and to make certain additional clarifying changes to Section 9-5.3843, including modifying numbering and phrasing.

CEQA: This ordinance is exempt from the provisions of the California Environmental Quality Act (CEQA) under CEQA Guidelines section 15061(b)(3) because it can be seen with certainty that there is no possibility that the Ordinance may have a significant effect on the environment, and under CEQA Guidelines section 15064(e), which exempts purely economic regulations
