6. NEW PUBLIC HEARING

6-1. PRE2023-0004 | Good Chance Project PDP | APN: 076-021-006 : - The applicant, Good Chance Management, LLC, request Preliminary Development Plan (PDP) review of a proposal to construct 13 residential units on 16.15-acres (APN 076-021-006). The proposed project would include a conventional single-family home with a detached accessory dwelling unit (ADU) on each of the 13 lots. The property is located on Somersville Road, south of James Donlon Blvd. near the entrance of the Black Diamond Mines Regional Preserve Park.

The purpose of a Preliminary Development Plan is to gather feedback from the Planning Commission and others in order for the applicant to become aware of concerns and/or issues prior to final development plan and tentative map submittal.

6-2 SP-23-01 | East Lone Tree Specific Plan Amendment Project | Slatten Ranch Road/Wicklow Road: - The City of Antioch is requesting to amend the East Lone Tree Specific Plan to modify the approval process for commercial development within the Regional Retail/Employment (CR/E) and Employment Retail (CE) designated parcels of the East Lone Tree Specific Plan. The project applies to APNs 053-072-003, 053-072-025, 053-072-026, and 056-120-095.

CEQA: In accordance with CEQA, the City has prepared a Supplemental Environmental Impact Report (SEIR), which determined all potentially significant environmental impacts for the potential ultimate buildout of the project would be mitigated to a less-than-significant level with incorporation of mitigation. The SEIR for the East Lone Tree Specific Plan Project was circulated for public review from January 11, 2024, to February 26, 2024, to solicit comments and input from the public. The City received four comment letters during the public review period. Minor revisions to the SEIR were required as a result of the comment letters, and no new significant information was identified during the comment period. Therefore, recirculation of the SEIR is not required.
