1. Adopt A Trail Program Update

(Note, this item was moved after item 2). Commissioner Matthews and ACM Helfenberger provided an update on the development of the Adopt A Trail program. The Commission provided feedback and thanked Commissioner Matthews for his work on the project. ACM Helfenberger hopes to launch the program in August.

2. Discussion of Potential Development of a Bicycle Pump Track

ACM Helfenberger provided background on the Bicycle Garden project, which could include a bicycle pump track. He then explained what a pump track is. Commissioner Ellis asked about the types of materials used and who the potential end users are. ACM Helfenberger responded that all of those questions are up for discussion and that the Commission would have the opportunity provide their preference. Commissioner Williams expressed enthusiasm for the concept and asked about whether the City's insurance would cover the amenity. ACM Helfenberger responded that issue had not yet been explored. Chair King asked who the intended audience of the Bicycle Garden was. ACM Helfenberger responded that it was intended for school age children and their families. The pump track would extend that to teens and adults. This spurred a discussion about the various potential users and how they may interact. More information on the Bicycle Garden will come to the Commission at a future meeting.

Citizens may also call Public Works during business hours at (925) 779-6950. Prohibited Water Uses:

Please keep in mind that per City of Antioch Municipal Code 6-10.04, the following water uses are always prohibited

- Permitting water to flow onto a sidewalk, driveway or street, or escape down a gutter, ditch or other service drain;
- 2. Outside watering that results in excessive flooding or runoff into a gutter, drain, walkway or street;
- Using City-furnished water for nonrecirculating decorative fountains or filling of decorative lakes or ponds;
- Washing of paved or other hard surface areas, including sidewalks, walkways, driveways, patios and parking areas with City-furnished water;
- 5. Failing to repair a controllable leak of water; and/or
- 6. Using a hose without an automatic shutoff nozzle.

in harmony. The Antioch Animal Services Center is responsible for the enforcement of Local and State Laws relating to the care, control, and protection of animals and of our citizens. Officers' responsibilities include picking up and confining stray, sick, injured, vicious and dead animals; issuance of dog licenses; patrolling the City streets; control of animal nuisance problems and animal euthanasia. The Animal Shelter also provides adoption, volunteer, and education programs.

Special features include:

- A room in which prospective pet owners can meet and interact with the animals
