### 4. PUBLIC HEARING

4-1. CREEKSIDE VINEYARDS AT SAND CREEK | UP2024-0008 | APN 057-050-024 - The applicant requests a minor use permit for the Creekside Vineyards at Sand Creek to proceed with mass grading of the project site. The Antioch Municipal code requires the issuance of a use permit prior to the construction of any phase of an approved P-D District. The intent of the use permit is to further clarify the details of the development being considered and to ensure that it complies with the established P-D.

**Recommendation:** Staff recommends that the Zoning Administrator approve a Use Permit to proceed with the grading and construction of the Creekside Vineyards at Sand Creek.

**CEQA:** The Creekside Vineyard at Sand Creek Environmental Impact Report (EIR) was certified on March 23, 2021. The work proposed with the Use Permit is consistent with the project EIR.
